The Athletic Account showed a bank balance as of August 31, 2021, of \$79,980.03, for a total Athletic Fund of \$79,980.03.

The Cafeteria Fund showed a balance of \$36,117.93, for a total School Service Fund balance of \$116,097.96.

The Bond Debt Retirement Fund showed a bank balance of \$927,790.19, for a total Debt Retirement Fund balance as of August 31, 2021, of \$927,790.19.

The Capital Bond Projects Fund showed a bank balance of \$12,601.38, less outstanding checks of (\$3,094.00), plus a MILAF Investment of \$735,223.54, for a total Capital Bond Projects Fund balance as of August 31, 2021, of \$744,730.92.
