December 9, 2025

The Board of Education of the Public Schools of Calumet, Laurium and Keweenaw held its regular monthly meeting on December 9, 2025, at 5:30 p.m., in the Board of Education Room.

Present were members: Phyllis Locatelli, Jason Wickstrom, Melanie Parker, Daniel Zubiena, Philip Halonen, and James Vertin. Absent was Adam Loukus. On motion, seconded (Halonen-Wickstrom) unanimous decision, minutes from previous meetings were approved.
